The role of each of the boards has been re-iterated and the meeting of the chief constable’s was designed as a workshop. The chief constables of Cleveland, Durham and Northumbria were also invited to that meeting. The first meeting of the PCCs takes place in February and will also be a workshop in style. The extent of the ambition of the YatH collaboration was/will be explored in both of those meetings.</p> <p>The Evolve collaboration with North Yorkshire, Cleveland and Durham continues to progress with CBRN, DVI and an integrated dog section all in implementation. The Integrated Major Crime Service will be considered by chief constables and PCCs in March, as will options for the integration of Legal services and Information, Rights &amp; Disclosure.</p>	<p>No exceptions to report</p>

		<p>Work continues to develop the protocols which sit under the section 22 agreement and also a timeline for the HR services work.</p> <p>Representatives from each of the enabling services for each force meet regularly to discuss progress against the business cases and to consider areas for collaboration.</p> <p>CC Jones has taken over the chair of the National Police Chief's Council Number 2 Region. This is the region which comprises the three Yorkshire forces, Humberside, Durham, Cleveland and Northumbria. There is a desire to work closer together, but the exact areas for collaborative activity are not yet agreed.</p>
