Nationally, people shout for the increase in Community Police to get local intel.</p> <p>If this is correct, why on earth do we pay for the 101-information line when we make a call and why does it take 16 minutes for someone to answer the calls?</p> <p>Why - as a ratepayer should I pay to impart information to the Police? Come on, for goodness sake, get your act together. You either want our help or you don't!</p> <p>Call charges are set nationally, and local forces have little influence over these. Calls to 101 cost 15p regardless of the length of time the call takes. Some mobile phone contracts do now include 101 calls so there are moves to make 101 more accessible.
