**Demonstrate effective engagement with young people to reduce the likelihood of them becoming victims of crime or Anti Social Behaviour (ASB) and Demonstrate effective engagement with young people to reduce the likelihood of them committing crime or ASB**

- **Children and Young People Strategy** - Launched in 2015 and reviewed in June 2016. Long term objectives are to protect and promote the welfare of young people , helping prevent them from becoming victims of crime and more from becoming offenders. To shift our focus of action and support for children and families to early intervention. Make young people more aware of the work of the North Yorkshire police and how to access the right services at the right time.
- **Safer Schools Partnership (SSP)** - Introduced to tackle key behavioural issues in schools. A pilot commenced at two schools in York and Scarborough in September 2015.
- **Crucial Crew** - Running for over 25 years and has a positive impact upon the young people who attend as part of annual school calendars. Evaluated in June 2016.
- **Safeguarding Training** - Child Sexual Exploitation Training rolled out to all staff across the force. Dedicated training days arranged for safeguarding and vulnerability.
- **Community Safety Hubs** – Set up to enhance the service provided by all partner agencies and improve outcomes for victims of crime and/or anti social behaviour



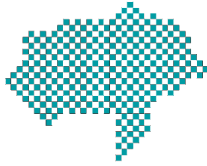

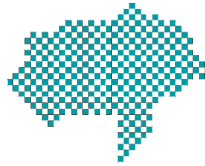
### Deliver improved services to victims

Extent to which repeat victimisation is tackled through support services for Domestic Abuse, Hate Crime, and other vulnerable victims

- **Independent Victim Advisor (IVA) service pilot** – will track repeat victimisation; next: approach to be rolled out to other services

Measuring victim satisfaction & confidence across the victim journey

- **Victim Journey:**
  - Previous local victim journey mapping refreshed to include newly commissioned support services; next: review areas for streamlining
  - Nationally Ministry of Justice submitting previously collated piece of work to Ministers; including North Yorkshire updates & good practice
- **Victim Satisfaction** – on the back of an independent review of support services for victims in 2015 a Feedback Questionnaire has been developed and is being piloted with a dip sample of victims; all victims with email addresses will be given the opportunity to participate

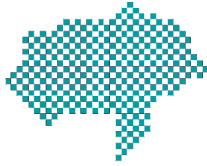

- Nominals subject to IOM are categorised as Gold, Silver or Bronze which dictates their level of management, those deemed as higher risk are set at Gold working down until they drop out of the Gold, Silver, Bronze system and are kept on for future monitoring. In any reporting period the SAC offences associated with each nominal are scored using a multiplier (3 for a charge, 2 for arrest/suspect, 1.5 for B grade intel and 1 for any other grade) these are then further multiplied based on the offence (x3 for burg. dwel, x2 for burg other, x1.5 for shop theft, x2 for other SAC offences or Handling/GETS and x1 for all other offences), a score is added for substance misuse, Probation Weighting and an aggravating multiplier; they are then categorised based on their score: **Gold 61+**, **Silver 41-60**, **Bronze 31-40**
