

Performance Monitoring/Management and Operational Priorities

- At a strategic level this meeting (The Corporate Performance & Scrutiny Group) and Executive Board consider performance in the broader context of financial and people data and consider progress against the delivery of the Police and Crime Plan
- The force runs its Tactical Tasking & Co-ordination Group (TTCG) meeting on a 3 month cycle rather than monthly. This meeting looks at predicted operational matters some 3 to 6 months in the future. Local TTCG meetings also run quarterly
- The Performance Steering Group now sits with the Operational Delivery Board meeting which also monitors progress against business plans and activity around HMIC inspections
- At a more local level the Assistant Chief Constable conducts quarterly Performance Reviews conferences which allow a more detailed assessment of localised operational and resourcing trends

Summarised commentary on current trends

Crime & ASB

- NYP has the lowest crime rates per 1000 population in England
- Crime and ASB are in line with last year (2015/16)
- Comparisons with 2014 must be seen in context of improved crime recording, increased reporting of historical crimes, and a significant rise in criminal damage which correlates with changes in crime recording rules meaning reports must be crimed within 24 hours rather than 72 hours.
- NYP have two long standing crime trends of note an increase in recording of "Other" (non rape) Sexual offences, and Violence without Injury.

Killed Seriously Injured (KSI) casualties

• Long term downward trend. <u>Provisional figures</u> for the first two months of this calendar year show a reduction in casualties on the previous two

Call Handling

- Performance continues to be a challenge in the Force Control Room.
- February performance showed a blip against a trend which had otherwise been moving in the right direction.
- Performance is forecast to improve within the coming months as new recruits complete their tutorship and are deployed into the control room.

Satisfaction

• Satisfaction remains high with more than 8 in 10 victims satisfied with service.

Public Confidence

- The latest data show 83.9% of the public are confident in NYP
- For public confidence measures NYP performs well compared to similar forces and national averages.

NYP'S TACTICAL RESPONSE

Rural Crime Task Force (RTF)

- **Prevention** Op Woollen has started across the County, offering proactive prevention advice, CMS sign up, and preventative marking to North Yorkshire's 9000 farms, with 750 sent to date and around a 25% response rate. Follow up visits to victims of poaching. Preventative marking events using Dot Peen machine at numerous livery yards, equestrian centres, private businesses, and sports clubs. Rural Watch continuing to develop in various areas across the force. Call it in campaign through Corporate Comms, focussing on the reporting and follow up to suspicious incidents. York Heritage Watch due to launch March 28th
- Enforcement 98 arrests, 71Reported for Summons, 38 vehicles seized by RTF since April. Op Checkpoint carried out March 8th with six neighbouring forces. Recent arrests for hare coursing, thefts from recycling centres, rural pub burglaries, quad thefts across entire county. Two significant investigations ongoing into fox hunting. OCG Wilderness likely to be archived, but OCG Purple which is Clepol based is ongoing, and therefore joint working continuing into this group who commit rural crime.
- Engagement / Reassurance Attendance at Parish Council Liaison meetings, auction marts, machinery sales, private events ongoing. Partnership work is ongoing with Yorkshire Dales, North Yorkshire Moors, and Angling Trust, to utilise volunteers to assist with this message. Training planned for all officer on Wildlife Crime to increase awareness, which is reinforced with poaching packs being distributed. Op Target and Op Aidant 2, are two weeks of action running until the end of March aimed at tackling vulnerability, and modern slavery. Various partners have been identified who can assist with addressing wellbeing of rural communities, and literature produced to be distributed in line with this week. Frequent publicity through Q1 Newsletter, social media presence, and articles in NFU.

NYP'S TACTICAL RESPONSE

Operation Hawk

- Operation Hawk is an NYP initiative to tackle travelling criminality and rural crime with the emphasis on the patrolling of our borders and targeting of vehicles and persons involved in criminal activities. In February the RCT have arrested 18 offenders recovered 1 stolen vehicle and seized 5 vehicles, the team has seized property to the value of £ 38,000(Inc. Drugs, cash and stolen vehicles). The NARCT have arrested 6 offenders, recovered 2 stolen vehicles and seized 15 vehicles. Together the teams have seized property to over the value of £ 83,000 Of note:
- The RCT sight a white van on the border of WYP and go onto stop the vehicle in Leeds. After smelling cannabis a search is conducted and a large amount of cannabis is found. NST officers carry out a Section 18 search of the offenders address where £14000 in cash was recovered.
- The RCT along with RPG attend Garforth area to support WYP due to a vehicle making off from officers.
- The NARCT stop a vehicle with a well known OCG in from the York area and with connections with South Yorkshire. After a search of the male and vehicle a £3500 in cash was located and the male was arrested for suspicion of money laundering.
- The NARCT and RPG respond to a report of a stolen Bobcat mini digger from near Ripon. After officers respond the vehicle is located and is brought to a stop. The 2 occupants of the vehicle were arrested on suspicion of burglary. There were also other various industrial tools recovered from the vehicle.
- The NARCT and RPG respond to an ANPR activation on the A19 south, a stolen Mercedes van from the Northumbria area. The vehicle was located and the driver arrested and transported to Harrogate Police Station.

While not committed with their primary roles RPG/FSU/Dogs/RTF/NST deploy onto Op Hawk as well as supporting local policing, successes include:

- FSU safely bring a vehicle to a stop using Pre-emptive tactics. In the vehicle was a Despondent High Risk Missing from home who had with him whisky and a large amount of prescribed tablets, stating his intention was to take the tablets. FSU calm the male down and take him to the Mental Health Suite.
- FSU and Dog officer respond to a report of a male in possession of a knife threatening to kill himself. FSU officers attend were they successfully negotiate with the male bringing the incident to a safe resolution. The male is detained and is seen by Ambulance staff.
- RPG and Dog section officers respond to a 2 in 1 burglary near Tadcaster, after following it to Leeds the vehicle goes off road where the 2 occupants decamp and make off on foot. After a search utilising Dog section the dog catches the offender leading to an arrest and the recovery of the vehicle.
- RPG attend a report of a male not breathing in Scarborough. Officer arrive prior to the ambulance and Tac Med is immediately given and CPR conducted. After 2 shocks the male starts to breathe and a pulse in regained.
- FSU and Dog offers stop a vehicle after an ANPR activation due to drugs markers. Officers carry out a search and hidden within a 2.5 litre thermos flask were a large amount of what was believed to be Class A drugs, the driver subsequently arrested.

Operation Checkpoint

- There have been 3 Op Checkpoint dates carried out so far this financial year, whereby local officers along with Farm watch and NYP officers from all the Proactive teams carry out cross border patrols.
- The next Op Checkpoint is scheduled for the 8th March 2017.

- **Op Corkscrew** Scarborough. Murder investigation. 27/12/16. Two charged and currently on remand awaiting trial.
- **Op Clue** York. Murder investigation. 15 year old female charged and currently remanded.
- **Op X-ray** Murder in Scarborough (Oct 2016). 2 persons charged & remanded, in addition 2 x robbery detections & work locally to protect vulnerable victims.
- **Op Essence** Claudia LAWRENCE
- **Op Woodcutter** Attempt murder investigation. York. 4 persons charged with conspiracy to murder.
- **Gross negligence manslaughter investigation**. Craven area. Male charged with gross negligence manslaughter and wilful neglect of a person. Pleaded guilty to wilful neglect. Currently serving prison sentence.
- **Op Curve** fatal agricultural incident at Tadcaster. Investigation jointly with HSE.
- **Op Conifer.** Murder investigation. York. 06/03/17. 19 year old male charged with murder and currently on remand.

Localised exceptions of note :

- Rises in **Harrogate District** are predominantly linked to rises in Cycle Theft and Criminal Damage. In context levels of cycle crime were significantly low over the whole of last year and therefore the rise is somewhat disproportionate. However a problem solving plan is in place.
- The rise in damage is the aggregation of small increases in crime vs the same month the previous year of around 10 to 20 extra offences. PSPs are in place.

- Performance is forecast to improve in the coming months as the recent recruits complete their tutorship and are deployed into the control room to boost resilience of staff. A further recruitment exercise has been held with staff beginning their training in May.

- Nationally forces are reporting increases in demand and longer wait times.

This takes into account officers leaving the service to retire or for other reasons as well as current gaps.

GLOSSARY

Reading the performance data

- The numbers shows performance against the previous year
- The dashboard graphic for operational crime, ASB and KSI data is an assessment of the latest month against a normal month based on the 2015/16 reporting period. The position of the needle describes the month results relative to a linear average. This allows for factors such as seasonal trends or the impact of single one off events to be explained. As the desired direction of travel can be up or down (e.g. increasing crime is negative but an increasing resolution % positive) the graphics alternate the red/green colouring accordingly.

Glossary

- ASB = <u>Anti-S</u>ocial <u>B</u>ehaviour
- CMS = Community Messaging System
- Crimes Against Society = These are crimes which do not have a "named victim" i.e.. the offence is against The Crown. These are usually (but not always) are as the direct result of police intervention/proactivity e.g a drugs operation. In North Yorkshire & City of York approx 10% of crimes are "Against Society" therefore it is important to make the clear distinction from Victim Based Crime.
- Fraud Offences = These are not included in the crime statistics as they are not reported by forces to the Home Office. Instead these crimes are passed to Action Fraud and statistics are collated by that agency
- I Grade = priority assigned by control room for an incident requiring Immediate police response
- KSI = A casualty <u>Killed or Seriously Injured as a result of a Road Traffic Collision on a public road</u>
- MCU = <u>Major Crime Unit</u>
- MO = <u>M</u>odus <u>O</u>perandi
- NPS = <u>New Psychoactive Substances</u> is the official term for Legal Highs
- NTE = <u>Night Time E</u>conomy
- NRCT = Northern Roads Crime Team Roads Policing with some firearms capability
- NST = <u>N</u>eighbourhood <u>Support Team a specialist unit which is deployed around the force through tactical bidding process</u>
- OPL = Over Prescribed Limit typically the term used to describe failing a breath test
- P&CP = Police & Crime Plan document setting out the Police & Crime Commissioner's priorities
- PCC = <u>Police & Crime Commissioner</u>
- PCSO = <u>Police</u> <u>Community</u> <u>Support</u> <u>Officer</u>
- PSG = <u>Performance Steering Group is an internal meeting chaired by a Chief Officer monitoring statistics & trends</u>
- Resolved Outcome = A crime where an offender has been dealt with through sanction or restorative justice.
- RPG = <u>R</u>oads <u>Policing Team</u>
- Sanction Detection = A historical method of looking at how crimes were resolved. A sanction detection includes where an offender is Charged, Cautioned, given a Penalty Notices for Disorder or Cannabis Warning or Fixed Penalty Notices, and where an offender has crimes Taken Into Consideration (TIC see below).
- TIC = <u>Taken Into Consideration</u> is typically where an offender admits to further offences to avoid potentially being pursued for these at a later date.
- TTCG = <u>Tactical Tasking & Co-ordination Group is an internal meeting which directs resources to tackle specific problems</u>
