North Yorkshire Police Crime Prevention Strategy

Outcomes

Effective outcomes via problem solving.

A quantifiable reduction in the threat, risk, harm, and demands associated with crime, anti-social behaviour and other preventable demand



Tackle drivers and vulnerabilities associated with victimisation

Reducing Demand - Through Effective, sustainable problem solving.

- Structured problem solving with partners

- The most appropriate cost effective intervention at the earliest opportunity

Cultural change.

Embed preventive policing as the core police function to maximise opportunities to prevent crime, decrease harm and reduce demand through problem solving

Secondary Crime Prevention.

With Partners - targeting those at high risk of a life of crime. (e.g. early Intervention, drug and alcohol and troubled families Programmes)

Tertiary Crime Prevention – Managing those who pose most risk.

- Deal with the criminal / individual, not just the crime or vulnerability
- Use the most appropriate intervention (e.g. targeted operations IOM, restorative justice, and the courts).
- Ensure national, regional and local analysis is used to allow all staff to assist in tackling high risk offenders (eg OCGs) and protecting their potential victims





1. Reducing demand through effective sustained problem solving

- Structured problem solving with partners
- Understanding problems
- Effective ownership of problems
- The most appropriate cost effective intervention at the earliest opportunity
- Evaluating and understanding interventions and outcomes.





1. Reducing demand through effective sustained problem solving cont...

- Long established approach to Problem Solving Plans (PSPs) based on SARA –
 Scanning / Analysis / Response / Evaluation
- New NICHE based process introduced for recording and storing problem solving plans
- New PSPs developed and accompanying guidance document published based on consultation and national best practice
- Supervisor review now required before problem solving plan closed on NICHE
- Dip sample quality assurance process being implemented
- Case Management System for Community Safety Hubs to enhance partnership approach to problem solving
- April 2017 assessing new "What Works Centre for Crime Reduction" crime reduction interventions cost benefit tool.





2. Primary Crime Prevention

- Preventing people from becoming victims
- Targeted and effective situational crime prevention focussing on Problem Analysis Triangle (Victim / Offender / Location) e.g. Get Safe On Line.





2. Primary Crime Prevention (cont)...

- Neighbourhood Policing "bedrock" of policing model increase in NPT numbers restructure to reflect needs of community April 2017
- Designing Out Crime Officers x2
- Received 110 various (planning) consultations between 29/11/2016 to 8/3/2017
- Of 25 developments awarded SBD accreditation in 2015 only 1 crime and 9 instances of ASB were reported in the 24 months up to the end of December 2016
- Licencing officers advise on licencing applications and target problem solving activity on problem premises
- In 2015, 20 members of staff attended College of Policing Crime Prevention Learning and Development Programme (CPLDP) and are 'Crime Reduction Champions'
- 37 PCSOs received basic training on security surveys
- Certificate in Neighbourhood Management rollout to NPT staff including module on problem solving
- Rural Crime Task Force focusing on specific needs of our rural communities.





3. Secondary Crime Prevention

With partners - targeting those at high risk of a life of crime

- Troubled Families
 - NYCC and CoY Council lead agencies
 - NYP Neighbourhood Policing Teams work to support the programme. Insp lead for each district
 - Dedicated analyst
- Integrated Offender Management
- No Wrong Door.





4. Tertiary Crime Prevention – managing those who pose most risk

Other areas of work to reduce demand

Youth Engagement

- New framework developed for delivery in schools, colleges and youth groups.
 Guidance document for use by NYP officers and staff for delivery of prevention inputs to young people
- Delivery of 'Sexting' guidance to school leads by Youth Officers to prevent criminalisation of young people
- NYYC (development of NYP and NYYC sub groups for Hate Crime, Abusive relationships and Stop search) - continuing the Big Conversation (4000 young people), including Cadets and hard to reach groups
- Engagement and Intervention work Lifestyle and Rock Challenge, Crucial Crew and Work Experience programme (June 2017)
- Upcoming Joint safeguarding work with NSPCC/ O2 in delivering awareness sessions to parents around Internet Safety.





Other areas of work to reduce demand (cont)...

Anti-Social Behaviour (ASB)

- Review of ASB processes
- Delivery of workshops as part of the Neighbourhood Management award to increase awareness of powers and tools available
- Community Safety Hubs rolled out with focus on reducing ASB and Public Safety and Welfare incidents
- Criminal Behaviour Order (CBO) process streamlined supported by staff development workshops
- Dispersal power process streamlined with improved authorisation process on NICHE for Inspectors to disrupt and prevent ASB incidents
- Working group developed for Civil injunction processes with NYP legal dept.





Future activity

- Neighbourhood Policing "Bedrock of Policing" in North Yorkshire Staff numbers increased – 11 Inspectors, 27 Sgts, 85 PCs, 314 PCSOs – focus on engagement, problem solving with partners, prevention and early intervention
- 2017/21 Police and Crime Plan 4 Priorities: Caring about the Vulnerable; Ambitious Collaboration; Reinforcing Local Policing; Enhancing the Customer Experience.
