

# Report on Public Consultation on Fire and Rescue Service and Police Collaboration

### August 2016

### **Background & Need for this Project**

The Policing and Crime Bill that is currently progressing through Parliament will provide a legal duty for emergency services to collaborate. As such it also provides the opportunity for Police and Crime Commissioners (PCC) to replace Fire Authorities and take responsibility for Fire and Rescue Services in their area. This has led the PCC for North Yorkshire to consider the potential of enhanced collaboration with North Yorkshire Fire and Rescue Service.

Various options are available for North Yorkshire Fire and Rescue Service to align either with North Yorkshire Police, or to align with a neighbouring Fire and Rescue Service, such as Humberside. Both options are viable and represent a clear choice to the people of North Yorkshire. With a decision of such magnitude for the future safeguarding of the people who live in North Yorkshire it is deemed appropriate that a careful and complete consultation is undertaken.

At this earliest stage it is important to obtain an initial sounding from the people of North Yorkshire to assess where the current consensus in opinion lies, and to input into the scope for a more detailed and complete consultation process which may have to follow.

### **Survey Design**

At the heart of this preliminary consultation is a need to understand what the public's appetite and immediate and instinctive response is to collaboration in both suggested forms – between North Yorkshire Police and North Yorkshire Fire and Rescue Service or between Fire and Rescue Services in North Yorkshire and Humberside.




Figure 1. Design overview

The survey was designed to measure the initial response to the concept or idea of greater collaboration or integration – are our public in favour of any collaboration? Subsequently the survey went on to test the public reaction to the two options on the table and then whether the inclusion of additional information about the rationale, the potential initial budget savings and the future of a more collaborative service would significantly change the initial reaction measured in the absence of any such information. This line of questioning is summarised in Figure 1 below:

The survey took just under 5 minutes to conduct, a copy of the questionnaire can be found attached in the Appendix.



### **Sample and Data Collection**

1050 North Yorkshire residents aged 18-75 were surveyed using a combination of telephone and face to face in street interviews. This is 50 more than proposed as we asked for an additional 50 as insurance against interviewers not being able to complete their shifts.

The telephone and face to face interviewers were given a quota to work to which was based upon population statistics for North Yorkshire sourced from The Office of National Statistics (ONS). The quota specified responses by district, age group, gender, and socio-economic group (SEG). The resulting data has been weighted to correct for any deviations from this specification. The final unweighted achieved sample is in the table below. (See questionnaire section in Appendix for target sample).

The sample of n=1050 provides estimates of proportions with a maximum confidence of +/- 3 % using the 95% significance level. Any statistically significant differences in the data by sub groups (District or Demographics) have been flagged in this report. Further details on confidence intervals at a District level can be found in the Appendix.

## **Findings**

#### From across North Yorkshire

Before we get into any differences by different Districts or population segments we shall focus on the findings for the population of North Yorkshire as a whole.

The first question we asked the public was whether they believe that greater integration between the fire, police and ambulance service in North Yorkshire is a good way to manage available resources and budgets. Over half of people (62%) believe this and only a fifth (22%) rejected this idea (See Figure 3 below).



Figure 3. Initial response to idea of integration. Base: All respondents n=1000

The concerns raised fall under 3 main areas:

A suspected fall in service levels through poorer coverage and less well trained staff



- Further Job and funding cuts
- A reduction in efficiency due to an increased organisation size and associated leadership issues

Figure 4. below shows that the majority of the population is in favour of greater integration and in favour of that integration being one of the two options on the table. The additional information provided does not significantly impact the overall proportion of people in favour of a change although different pieces of information do encourage support from different people, the result being that **73**% of people were in favour of one of the options on the table at some point during the questioning.




Figure 4. Preferences and Option Ratings. Base: All respondents n=1050

Figure 4 also shows how there is an overwhelming preference for Option I (Greater collaboration between the Police and Fire Service in North Yorkshire) over Option 2 (Cross border collaboration between Fire Services involving North Yorkshire and Humberside). This preference is underpinned by a higher average rating of Option I compared to Option 2 (Maximum average score given being 7.6 out of 10 for Option I compared to 5.8 out of 10 for Option 2).




Figure 5. Forced choice preference and management preferences. Base: All respondents n=1050

We went on to ask whether, if the respondent had to choose between the two options, which would they prefer. The results of this are in Figure 5 and again show an overwhelming preference for Option I (Greater collaboration between the Police and Fire Service in North Yorkshire). When asked whom should manage the collaboration, over half of people preferred it to be the Police & Crime Commissioner. Preference for the Police & Crime Commissioner was in the order of 2:1 in favour versus a committee of elected councillors. The largest proportion expressed a strong preference (30%).

### **Findings by District**




Figure 6. Key data by District. Base: All Respondents

We found some variations by District which are displayed on the map below (Figure 6). Whilst we did find some statistically significant differences (notably Scarborough and Selby), the main picture is the same, i.e. a majority preference for greater integration/collaboration and for Option I (Greater collaboration between the Police and Fire Service in North Yorkshire). Selby in particular has an adjacency and perhaps a sense of affinity with Humberside but the overall preference there remained overwhelmingly in favour of a North Yorkshire focused collaboration.

#### Variations by other sub groups

Statistically speaking, women are more likely to be supportive of more integration across all questions asked (68% versus 62% for support based on financial savings) however it is still supported by the majority of both genders. There's no strong evidence of differences by gender with regards to what is the preferred option for further integration.

There's no strong evidence of a variation in support for more integration by different age groups, SEGs or whether the respondent was a Council Tax payer. Nor is there with what the preferred option would be – Option I is the preferred option for the majority (Greater collaboration between the Police and Fire Service in North Yorkshire).

#### **Conclusions**

The results from this representative and robust sample of North Yorkshire residents is clear. When asked to choose only between the two options, the preference for a North Yorkshire collaboration model outweighs a service based collaboration by 5:1. It also underlines that this is an immediate and instinctive response. The revelation around more details related to the level of potential savings did little to sway the majority opinion.

However it is important in developing plans around a closer collaboration or more integrated fire and police service to be aware of the publics' main areas of concern which seem to focus on falls in service levels, funding cuts and issues around leadership and specifically what that means in terms of response and efficiency. This research makes it clear that most people understand the benefits of change but are cautious about the motives behind change.

Note: The figures quoted above are the maximum confidence intervals and relates to an answer proportion of 50%. The more extreme the answer proportion (e.g. 10% or 90%) the lower the confidence interval will be. The significance level refers to how sure we can be that the total population result (i.e. if we'd spoken to everyone) would fall within the confidence interval.

The data was weighted to the following profile.
