Police Custody



- North Yorkshire Police operate a centralised custody model
- Three custody suites operating 24/7 at Harrogate,
 Scarborough & York
- Staffed by police custody sergeants and civilian detention officers with an custody manager (Inspector) responsible for each suite.
- High risk environment managing the complex needs of suspects and keeping people safe.
- Standards and Expectations
- Subject to unannounced inspections

Risk Assessment and support



- Embedded healthcare in custody
- Liaison & Diversion service
- Referral pathways
- Care plans and observation levels
- Deaths in and after police custody
- Pre-Release Risk Assessments

Arrest or Voluntary Attendance?



Arrest

There are at least reasonable grounds to suspect the person's involvement in the commission of a criminal offence.

There are reasonable grounds for believing that the person's arrest is necessary.

Necessity

The officer must consider whether the investigation can be effectively carried out by less intrusive means. Must take into account

- the situation of the victim
- the nature of the offence
- the circumstances of the suspect and;
- the needs of the investigation.

Where the arrest criteria is not met then the suspect may be invited to voluntarily attend an interview under caution

Voluntary Attendance (VA) process



- Pre-arranged Interviews under caution at a VA room
- Not under arrest and free to leave at any stage
- Free and independent legal advice
- All the same disposals available as those arrested charge to court, out of court disposals
- Risk assessments conducted
- VA Training courses introduced in 2015



The use of pre charge bail




- Bail can be used pre and post charge to prevent offending, protect victims and witnesses and to manage the suspect.
- Police and Crime Act 2017 included a significant reform of pre-charge bail
- A presumption of releasing a suspect without bail unless deemed 'necessary and proportionate' to bail.
- A new interim disposal of 'Release not on bail but under investigation'
- Huge reduction in use of pre charge bail


Drink and Drug Driving 2015-2019



Drink Driving





Drug Driving



Drink and Drug Drive Arrests - Force wide









Prosecutions for Drink and Drug Drive arrests




Drug Driving
