Domestic Abuse



- Police incident data for domestic abuse cover reports of:
- threatening behaviour, violence or abuse
 - Psychological
 - Physical
 - Sexual
 - financial
 - emotional
- between adults aged 16 years and over, who are or have been intimate partners or family members regardless of gender or sexuality


Domestic Abuse – Nationally



- Demand has risen dramatically.
- Nationally 732,444 offences reported
- 14% of all crime reports to police
- Improve police's understanding of coercive and controlling behaviour
- Decline in victim complaints to court
- Prosecution rated and outcomes

MARAC Multi Agency Risk Assessment Conference



- A MARAC is a meeting where information is shared on the highest risk domestic abuse cases between representatives from statutory and voluntary sectors.
- After sharing information they have about the victim, perpetrator and any children in the family, the representatives discuss options for increasing the safety of the victim and turn these into an action plan.
- Over 270 MARACs operate over the UK we currently have 5 in North Yorkshire which vary in frequency and the number of cases heard.
- We currently hear 900 cases a year at MARAC in North Yorkshire and York.

MATAC — Perpetrator management

 Multi agency tasking and coordination is key to driving change in the behavious serial perpetrators of domestic abuse- those who commit the most harm

- 60 telephone conferences held over 9 dates
- 45 nominals screened to date
- 5 nominals adopted as referrals from partners
- Male, female and 16 year olds adopted
- 18 adopted into green route
- 12 adopted into red route having continued to offend
- Remainder haven't reoffended but not wanting support or are to be heard at next meeting
- 3 meetings on average before discharge voluntary partners
- Effective information sharing leading to expedited arrest and re introduction to the criminal justice system

- From 2016 2019 NYP were part of The Home Office funded 'Domestic Abuse: A Whole Systems
 Approach' (DAWSA) project. DAWSA was developed by Northumbria OPCC and Northumbria
 Police along with partners in the OPCC and police from five other regional forces.
- The aim of the programme was to transform domestic abuse services by giving Police, partner agencies and victims the ability to truly deliver lasting change. The project injected resource into local systems to enable them to explore and deliver innovative approaches with the aim of improving responses to domestic abuse, and therefore, the experiences and outcomes of victims.
- The DAWSA project was divided into three themes and NYP implemented activities under each theme. These include:
 - MATAC
 - Domestic Abuse Scrutiny Panel
 - Child & Family Court Work
- NYP are now involved in DAWSA: The Next Steps which has been designated as a Home Office Tier
 2 Transformation Project. The aim of the project is to maximise the benefits of the original DAWSA achievements. Elements of the Next Steps Project include:
 - National sharing of DAWSA best practice through a digital toolkit and knowledge sharing events, best practice and outcomes, nationally
 - Continued embedding of priority original DAWSA elements across the regional group, to
 enable processes to be further tested and evaluation data obtained. In North Yorkshire we
 are continuing with the MATAC process which we have received Home Office funding for
 19/20. Sustainability options are currently being explored to enable NYP to embed MATAC
 into business as usual.

Outcomes and Initiatives

- Developing engagement & forums forcewide by Domestic Abuse
 Coordinators driven through the Operational Group
- Sharing of ideas within region (Domestic abuse car. Officer and IDVA together as secondary attendance)
- Co-locating with IDAS. Early considerations
- MATAC roles (coordinator and Intelligence officer) developing opportunities to manage stalking offenders
- Domestic Abuse Scrutiny Panel
- Commissions Domestic Abuse Victim Survey
