

## North Yorkshire PFCC – Tender Opportunity

### New Criminal Justice Diversionary Support Services



- The Police, Fire & Crime Commissioner for North Yorkshire ("PFCC") is issuing an invitation to tender for the provision of Diversionary Support Services for first-time entrants, low level offenders and those at risk of entering the criminal justice system, in North Yorkshire and the City of York
- An open, competitive procurement process will take place, which is due to commence in November 2020
- Service delivery will be due to commence in May 2021
- The tender will be split into three lots, the PFCC is seeking one provider per lot; this may include however sub-contracting or consortia arrangements involving a number of organisations. Bidders may apply for one, two or all Lots
- The intention is to award any resulting Contract(s) for a period of 36 months (3 years), commencing on the 3rd May 2021, with an extension option of two periods of 12 months from 3<sup>rd</sup> May 2024 to 30<sup>th</sup> April 2026
- The PFCC is inviting bids up to the maximum Contract Value of £470,000 per annum

# Lot 1 – Diversionary Support Services for Adult Women (18+)



The service will consist of two elements:

- The offer of a community-based support service, on a voluntary basis, to women who may be at risk of entering the criminal justice system or who are known to North Yorkshire Police
- A mandatory pre-court diversionary support service for women, at point of arrest or voluntary attendance at police custody (which would normally result in a caution or charge)
- Anticipated Volumes:
- Max Caseload per annum 412
- Max caseload at any one time 139

#### Aims of the service:

- Reduce the number of female first-time entrants
- Reduce the reoffending rates of women
- Prevent offending by addressing the criminogenic needs of women and evidencing progress against these

**Service Model:** Prevent offending / reduce reoffending by assessing / identifying the needs of women across the criminogenic pathways and delivering support / interventions to address those needs, monitoring progress

Value: £165,000 per annum, maximum contract value of £495,000 for the initial three year period

### Lot 2 – Diversionary Support Services for Men aged 18-25

Commissioner

The service will consist of two elements:

- The offer of a community-based support service, on a voluntary basis, to men aged 18-25 who may be at risk of entering the criminal justice system or who are known to North Yorkshire Police.
- A mandatory pre-court diversionary support service for men aged 18-25, at point of arrest or voluntary attendance at police custody (which would normally result in a caution or charge)

#### **Anticipated Volumes:**

- Max Caseload per annum 300
- Max caseload at any one time 95

#### Aims of the service:

- Reduce the number of first-time entrants for men aged 18-25
- Reduce the reoffending rates of men aged 18-25
- Prevent offending by addressing the criminogenic needs of the individual's and evidencing progress against these.

**Service Model:** Prevent offending / reduce reoffending by assessing / identifying the needs of individual's across the criminogenic pathways and delivering support / interventions to address those needs, monitoring progress

#### Value: £120,000 per annum, maximum contract value of £360,000 for the initial three year period

# Lot 3 – Diversionary Support Services for young people aged 10 - 17

A Diversionary Engagement & Support Service for young people aged 10 -17. The service will target those children and young people:

- Who are deemed to be at risk of offending
- Who are committing very low-level offending
- Who are committing anti-social behaviour incidents

The support will be offered on a voluntary basis

Anticipated Volumes – Between 250 and 450 per annum

#### Aims of the service:

- Reduce the number of children and young people entering the Criminal Justice System
- Promote the safety and wellbeing of children and young people who may be experiencing or at risk of hidden harms
- Reduce crime and Anti-Social Behaviour incidents in localised areas of North Yorkshire and the City of York
- Prevent offending by addressing the criminogenic needs of the young people and evidencing progress against these

**Service Model:** A mixed approach, consisting of assertive engagement and to prevent offending / reduce reoffending by assessing / identifying the needs of the young people across the criminogenic pathways and delivering support / interventions to address those needs, monitoring progress

#### Value: £185,000 per annum, maximum contract value of £555,000 for the initial three year period
