# **BACKGROUND & CONTEXT**

NATIONAL CHILD PROTECTION INSPECTION (NCPI)



- The HMICFRS CP Inspection took place in November 2021. A draft version of the report was received in January so factual accuracy checks could be conducted.
- 10 recommendations, 5 of which were for immediate attention, and 5 to be progressed within 3 months.
- NYP started work immediately on the recommendations and the Chief Officer Team fully accepted the findings



#### NYP IS MAKING PROGRESS IN MAKING SURE OFFICERS OBTAIN AND RECORD CHILDREN'S CONCERNS AND VIEWS (INCLUDING NOTING THEIR BEHAVIOUR AND DEMEANOUR)

"We recommend that within three months North Yorkshire Police acts to make sure officers obtain and record children's concerns and views (including noting their behaviour and demeanour). This will help influence the decisions the force makes about them."





#### NYP IS PUTTING IN PLACE ROBUST PROCESSES TO REVIEW HOW WELL CONTROL ROOM STAFF PERFORM IN RELATION TO OFFICERS ATTENDING INCIDENTS

"We recommend that North Yorkshire Police immediately reviews its processes regarding incidents relating to child protection, paying particular attention to how control room staff make decisions on officer response."

### NYP HAS REVIEWED HOW IT RECORDS INCIDENTS INVOLVING MISSING CHILDREN AND IN PARTICULAR, UNDERSTANDING WHY THEY GO MISSING AND COMPLETING PPNS ROBUSTLY



"We recommend that North Yorkshire Police immediately improves its missing children arrangements and practices."



#### NYP ARE MAKING STEPS TO WORK MORE CLOSELY WITH ITS SAFEGUARDING PARTNERS, AND REVIEWING THE STRUCTURE AND PRACTICES OF MULTI-AGENCY RISK MANAGEMENT MEETINGS, SPECIFICALLY ABOUT CHILDREN AT RISK OF EXPLOITATION

"We recommend that North Yorkshire Police immediately starts working more closely with its safeguarding partners, and that it reviews the structure and practices of its multi-agency risk management meeting"



### NYP ARE ALLOCATING RESOURCES TO HELP ITS CSE TEAM IMPROVE ITS UNDERSTANDING OF CSE, IN PARTICULAR: IMPROVING STAFF AWARENESS, KNOWLEDGE AND SKILLS IN THIS AREA OF WORK

"We recommend that within three months North Yorkshire Police improves its understanding of CSE"



#### TRAINING ADJUSTMENTS HAVE BEEN MADE TO ENSURE FRONTLINE OFFICERS ARE INCREASING THE AMOUNT OF INTELLIGENCE THEY ARE PUTTING ON NICHE AND RELEVANT INFORMATION IS RECORDED ABOUT RSOS


"We recommend that North Yorkshire Police immediately improves the way it manages registered sex offenders"



#### NYP ARE REVIEWING AND ACTIONING HOW TO BEST MAKE SURE APPROPRIATE ADULTS PROMPTLY ATTEND POLICE STATIONS-

"We recommend that within three months North Yorkshire Police reviews how it manages the detention of children. The force should do this jointly with children's social care (CSC) services, youth offending services and other partner agency's."
