APPROACH



Based on our understanding of risk in York and North Yorkshire, our Prevention Service focuses on 3 priority areas:



Accidental dwelling fire risk and fatality / injury risk

Road risk and fatality / serious injury risk

Water risk; flooding, rescues and other water related risks

Our prevention approach consists of: targeted interventions; partnership working and collaboration; communications and engagement; and safeguarding.

We have responded to community concerns about speeding by delivering over 200 speed data logger deployments across county (Apr 22 – Mar 23). We have introduced a Virtual Reality intervention to deliver at specific events on our youth engagement programme (eg LIFE courses). We have delivered 106 Firebike engagements (Apr 22 – Mar 23).		
We have delivered 15 Biker Down courses (Apr 22 – Mar 23) to over 178 individuals (delivered in targeted roadside locations, Fire Stations and biker 'meet ups').

MANAGING PERFORMANCE



- Home fire safety Performance Dashboards used to report outstanding requests to districts and report into Service Delivery
- Speed data logger deployments managed by Prevention and fed into Road Safety Task Group meetings
- Quality Assurance Framework being implemented and trialled in service to ensure our interventions are being delivered to a high standard, areas of improvement will be highlighted and managed locally
- Community Risk Profile data used to assist decisions on targeted work in communities to ensure performance against risk profile
- Request and listen to feedback from Prevention Team, the wider organisation and our partners

WORKING WELL



How effective is the FRS at preventing fires and other risks?



North Yorkshire Fire and Rescue Service is good at preventing fires and other risks.

North Yorkshire Fire and Rescue Service required improvement in its 2018/19 assessment.

- The culture of and commitment to prevention and continuous learning across the entire service
- Reaching more high risk / high consequence individuals / groups in rural areas
- Behavioural change through youth intervention
- Public Safety Service (recognised as Promising Practice)
- Relationship with our regional Fire and Rescue Services
- Innovative new work with partners such as Yorkshire Ambulance Service with a SafeLincs App

CHALLENGES



- Accurate use of Data
- Prevention Team expansion. We are gradually developing the Prevention Team which has begun with the introduction of a new Head of Early Intervention and Prevention, but the existing team is relatively small which can impact resilience.
- Organisational directional / cultural change.
- At times our partner organisations resources and capacity to work together.
- At times, new legislation, new requirements, new standards, and new guidance which requires us to complete project / programme activity in addition to Business as Usual.
- The impact of not being able to prevent all harm, and the emotional impact to our people when the public we seek to protect experience serious injuries and fatalities.

IMPROVEMENT



- We are currently creating a new Prevention Strategy, Tactical Delivery Plan and Benefits Framework to drive activity and measure impact
- We are exploring ICT solutions which help us to use new data sets to improve targeting of prevention activity
- We hope to expand the capacity of the Prevention Team further, in accordance with the Risk and Resource Model
- We plan to expand the reach of the Public Safety Service
- We now have a Post Incident Engagement process, providing a preventative and 'community trauma' response
- We are making improvements in Assurance and Evaluation of prevention activity
- We are developing our Safeguarding policy, processes and practices
- We plan to better understand the accessibility and impact of our services to minoritised individuals and groups
- We are investing into developing relationships with our Community Safety Partnerships and NHS partners
- We are expanding our learning around 'near misses' and applying that learning directly back into prevention services

IMPACT



Our impact / performance framework is being refined to ensure we can evidence the requirements contained within:

- The Prevention Fire Standard ie:
- Improved safety, health and wellbeing of communities leading to a **reduction in incidents**, injuries, serious injuries and fatalities.
- Improved competency in the prevention workforce, including an increase in the number of employees and volunteers trained.
- Improved evaluation to increase the efficiency and effectiveness of prevention activities.
- Risk and Resource Model
- Fire and Rescue Plan Priorities and Objectives
- HMICFRS Criteria
